- Emphasized the need for PIREPs
  - 4 audiences, helps with current flights, ATC traffic flow, updated weather forecasts and and with refining NWS predictive models
  - o If you file PIREPs, and can check on them, verify they are there and accurate
  - o If problems, call 455-1600 (daytime) or 455-1605/floor supervisor (nighttime)
- Airport Support Network (ASN) needs volunteers for a number of Alaskan airports
