## **Airport Police and Fire**

Spring is here and with it, we expect to see an uptick in activity on the east ramp. In the past we have seen associated minor increases in criminal activity to include theft, damage to aircraft and trespassing.

#### **ANC/FAI Dispatch Support**



Fai continues to provide dispatch support to both ANC and local AST dispatch centers. We have added 2 new full time dispatchers and are currently one employee shy of fully staffed. Recruitment for the remaining position should occur in late June. Current equitable pay issues continue to be a challenge that potentially impact current staffing levels.



# **APF Staffing Outlook**

Current Police and Fire Officer staffing is full at 26 sworn officers with 1 in a training cycle

Dispatch staffing is 5 of 8 with two new hires in training and 1 recruitment scheduled to start in late June/early July

Department Administrative Assistant has recently been selected and is pending state hiring approval

Chief Stevener has officially announced retirement effective June 30<sup>th</sup>. Recruitment for successor is currently in process

1-2 additional retirements are anticipated in the next 12-18 months

No decrease in quality of service is anticipated due to these departures.
